- 1. Call to Order, Land Acknowledgement Dennis
 - Tonight's meeting is to review the Draft amendment to the Bylaws, io groups, privacy policy
- Welcome and Introductions AllAdoption of Agenda Dennis

- 4. Adoption of previous minutes Dennis
 - Tabled until the next meeting.
- 5. Financial Report Abdul
 - Abdul: Did get the \$1,000 received from National. This was a grant from Canada Life (coordinated through an application by Ed). We now have a balance of just under \$20K. \$19,457.22.
- 6. Committee Work Reports
 - a. Bylaws Judy
 - Judy: Did circulate them today reached at end of discussion. Could not resign in the last year. Includes that change. Michelle: There was not process for appeal.

MOTION Judy to post as drafted to the site for the membership to review., Ed seconded. No one opposed. ADOPTED

- Will post on website and send out to membership. Needs 60 days. 30 days minimum for notification to membership. Would need it to go to august meeting. If there is significant input, we can delay vote until September. Dennis: Might be issues in which case could delay to Sept. Ed: Absolute latest is Jul 13 notification for the Aug 12 meeting. Michelle: Were there a lot of changes. Judy: Yes. Dennis: Submit the clean version. Aug meeting is in person.
- Ed to send email to the membership. Scott: Would be good to have the one page summary similar to past. ACTION Judy to do a one pager saying aiming for Aug 12, zoom link available.
- b. Policies and Procedures Manual Dennis
 - Nothing done with it yet. Was waiting for the bylaws. Dennis: I would start with things needed from the bylaws, and circulate it once it fits the draft-amendment bylaws.
- c. Observatory Committee Russell
 - Russell: Since last meeting we did the cleanup, had the wall paneling ripped out, Ed cleaned out junction boxes, power back on, all we need for the warm room is get the objects out stored in there. Warm room needs tidying so it can be used. Dome has potential structural issues, rot in the frame and base plate, baseplate boards are

very spongy, and need inspection. The committee will meet sometime this month. For sure, the warm room will be open to membership for BBQ. Don't think the observatory can open up yet, but warm room for the picnic should be okay. Need to decide if the dome is salvageable. It is decluttering in the warm room. Dennis: Still mud in the observatory. Need a fan out there for circulation. Russell: Was trying to rip up the subfloor of the bathroom, 2 or 3 boards of subfloor, need circular saw for that. Jay: Mentioned rip it down to studs. Probably still damage from a past flood. There was a lot of rat feces in the insulation. We had 2 lawn mowers out there. Re: lawn, mostly cut around the pad; Michelle hasn't inquired about UM getting the larger area mown. Hoping that a membership group can cut around the pad, in prep for the BBQ. Will ask Danielle.

Dennis: Porta potty, how long do we need one? Given on the shape of the dome.
 Russell: Could book 1 month and then extend it. Michelle: What is wrong with composting toilet? Russell: Not until the floor is sorted and telling the membership not to go out. We don't want anyone in the dome structure for safety reasons.
 Abdul inquired about usage, and Michelle indicated there is a core of users. \$257.50 + tax.

MOTION Russell moved to make expenditure for porta-potty as quoted in his email Michelle: Seconded. ADOPTED Up to \$300 for one month.

- Mark: Anybody with Civil Eng background? May need that for the assistance report. Structure has not yet been inspected.
- Dennis: To Russell can you handle ordering? Russell: I can do the correspondence for the toilet delivery, will need someone to go out there. Dennis: By the hydro pole is good because is packed and stable. Russell: Will request asap.
- When is the BBQ? ACTION Ed to send invite on this for July 8, 6:00.

e. Finance Committee

Abdul/Mark Irvine

- Mark: Financial policies and procedures. Included a lot of things not included for an
 organization like ours. This is a base. Down the road of incorporation and
 potentially charity, these are foundational. Things the CRA will want to see.
- Section by section. There is the TOC, then purpose of policy, then in the ... might have things needing to be tweaked. Chaired by president and treasurer. There are some resp for the president as far as governance and due diligence, monetary items, oversight, follow GAAP. Don't know that charities need to follow IFRS. Large undertaking, but at some point charities will need to follow that, principle is transparency. Also want controls, segregation of tasks, ease of process, but small amounts of petty cash are allowed for convenience. Now using an Excel spreadsheet. No request yet to move to financial package, but good thing to do. Would need to set values on assets. Always use market value.
- <u>Budgets</u> a key control in the organization. we set budgets, never perfect, say why we thought we did when we did. We want to move the organization ahead financially and the budget is the way to do that. For financial statements, good practice to issue at end of the month, but often organizations look a month in arrears. But I think we have been up to date on a cash basis. Would want to know what spending on various categories.

- A key thing for charities is an audit, not have to be external, can have audit
 committee but not same people doing the finances. Could be a membership
 committee. There is interaction with the people transacting and the final report.
 The report is a useful gov and communications tool for the org. It is private. It is
 good to have that report for getting a loan.
- Banking, process to select is general guidelines. Banks follow different guidelines for charities
- Operating acct guidelines, sufficient funds to pay our bills. Cash mgmt. process to ensure sufficient funds in the operating acct.
- Michelle: NPO or charity? Dennis: First step is not for profit.
- Dennis: "Policies and procedures which are not specifically addressed by this
 document may be determined by the President when the financial impact is not
 over \$1000 for any fiscal year" Should be \$200. Dennis reviewed the other dollar
 amounts. The president can go to \$200. Over that comes to council. Would rather
 it be conservative to start. Mark: President has discretion, but no discretion for
 reporting.
- <u>Banking</u> If excess funds rely on the committee to invest prudently. For now ends
 up in savings acct, e.g., a GIC or other
- <u>Deposits</u> Whenever possible the person collecting the cash should not be depositing it. E.g., for selling small things at a public event. Not the same person to deposit. Judy: For deposits, you could say segregation of duties is a key financial control. Dennis: So the person selling the calendars should not be depositing the cash. Mark: Sometimes not possible in small organization. Not necessarily a day-1 thing, need to evolve. Michelle: Why could it not be person on financial committee, might be overkill in some cases. Mark: Doesn't have to be in person. E.g., expense reporting. Mark: Outlook has an ability to do a delegate. You can delegate your authority but not abdicate the authority. Could have in our organization delegate from one person to another, would need a record of that.
- <u>Cheque signing</u> should not have one person pre-sign a bunch of two signature cheques. Never a good practice. Usually the first signor is the least senior and then the second signor is the senior who confirms all the approval to release cash. Michelle: The porta potty? Mark: Russell has the approve to transact. If it comes in at \$1000 we would ask is a difference cost. The people signing the cheque need to know the whole story.
- Petty cash For wase of transacting, this is a risk continuity, are we willing to risk \$100 of RASC money, e.g., float for calendars. The person with the cash has to have an accts receivable. It goes to a person, not a group. That person must replenish it. We need some flexibility in the policy. You can't have \$1,000 with 10 \$100 advances, that would be circumventing.
- Reconciliation controls, whoever holding the cash should be in the report. Dennis: Stopping discussion on this for now.

 Russell: Have the registration form for SWSP is already to go on the website. Will send the form through Ed. The dark sky preserve we have a public event, will be inviting special guests (including Wilfred Buck, and the chief of the First Nation, the mayor of Glenboro, and a few other VIPs), no other updates for now. Registration starting later this week. For cost, doing \$30 per campsite including members and family of members regardless of tent or RV.
